### Shared Zone Reminder

There has been a recent increase in interactions involving vehicles, bicycles and pedestrians on campus.

It is important to remember that the speed limit for cars, bicycles, electric vehicles and scooters etc is 10kph. This speed is a reasonable jogging pace, so you must not be driving or riding any faster than this. The campus is pedestrian priority which means ALL vehicles must give way to pedestrians on any road on campus (in other words the whole campus is one big pedestrian crossing). Give way means the driver or rider must slow down and, if necessary, stop to avoid a collision. Take care everywhere as there are many blind corners, parked vehicles, bollards, kerb and the like. ## HR Embracing the 'Return and Earn' Scheme

This week is 'National Recycling Week' and HR has commenced a War on Waste by embracing the NSW Government's Return and Earn Bottle Deposit Scheme . The initiative began rolling out across NSW on 1 December 2017, with the aim of reducing litter by 40% by 2020.

UNSW was the first University in NSW to introduce a reverse vending machine in February this year, located near the Physics Lawn. The reverse vending machine is the cleanest and most efficient way to recycle glass, plastic, and aluminium cans, cartons and bottles.

HR will embrace this initiative starting with three new bottle recycling bins in prominent locations on each HR floor in The Chancellery (Ground Floor, Level 1, Level 3).

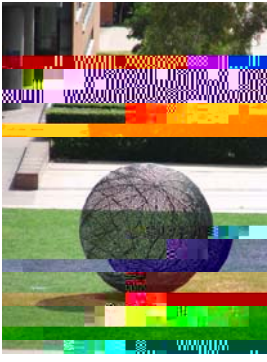


## Go Home on Time Day - 21 November 2018

## UniSuper Seminar - *Investment Market Outlook* - 30 November 2018 - 12.30pm-1.30pm

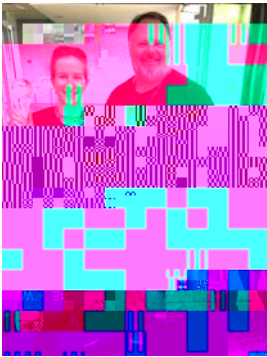
Understanding how the market works is vital for helping you make informed decisions on how you invest your super.

## Review of Australian Standard AS/NZS2243.3

The Australian Standard AS/NZS2243.3 'Safety in laboratories Part 3 Microbiological safety and containment' is still under review and a second draft will very shortly be available for a 6-week consultation period. We will let you know when it is available. The first draft attracted a huge number of comments, which is one reason for such a delay in finalising the document. The second draft aligns with the new 'ISO 35001 Biorisk management for laboratories and other related organisations'. It also includes aspects of the withdrawn standard AS/NZS2647 'Biological safety cabinets - Installation and use', which was withdrawn some time ago without providing the information in any other document.

## Lesson Learnt - Asbestos

Recently one of our research units wanted to make modifications to one of their labs. As they wanted the work to proceed quickly, they organised the construction themselves. However, once work was underway, a material was found behind one wall that was potentially asbestos. Work was immediately stopped while the material was assessed and removed. This unexpected discovery could potentially have exposed workers to hazardous material and delayed the project considerably.

Had the work been organised by Estate Management, the Asbestos

Register would have been checked before the commencement of work and Estate Management's streamlined asbestos remediation procedures would have been implemented, saving time and greatly reducing the risk of accidental exposure.

So remember, any structural modifications to floors or walls must always go through Estate Management.
